

AGREEMENT FOR AUTO BUYING ASSISTANT SERVICES

This agreement is entered into by and between **Auto Buying Assistant LLC**, hereafter Assisting (**Client Name**) in the Selling of vehicle and boat.

FOR AND IN CONSIDERATION OF Four Hundred Ninty Nine -- (\$499.00) and other good and valuable considerations the receipt and sufficiency of which is hereby acknowledged, the undersigned (**Client Name**) does hereby covenant, contract and agree as follows:

1. **Detail of Services: Auto Buying Assistant LLC** is hereby engaged to perform consulting services for (**Client Name**) regarding the following: Providing Assistant in Selling a Vehicle, Boat, RV or Motorcycle. Auto Buying Assistant will make every effort to sell the item in a reasonable time but does not guarantee a time frame of items being sold at all.
2. **Consulting Fee: (Client Name)** agrees to pay to **Auto Buying Assistant LLC** as follows:
 - Assist in Purchasing - \$289.00 dollars. (Flat Rate)**
 - Hourly rate of \$49.00 dollars. (Consulting or additional time used in relation to deal)**
 - Broker & Listing Fee - \$499.00 dollars.**
 - Consultation (First one free): \$0.00 dollars - \$49.00 per hour there after**

Payment shall be made as follows: Auto Buying Assistant at the time of contract agreement.

3. **Limited Services/Confidential Information: Auto Buying Assistant LLC** will assist (**Client Name**) accordance with the scope of services. Services not included in Scope of Services may be performed by **Auto Buying Assistant LLC** at the request of (**Client Name**) at the hourly fee of **\$49.00 dollars.**

Auto Buying Assistant LLC expressly agrees not to divulge, publish or communicate any information regarding their client's or their financial conditions to any person without the express written consent of their client. All information obtained by Auto Buying Assistant LLC during this engagement and all suggestions and recommendations received by client's shall remain the property of client's and **Auto Buying Assistant LLC** shall keep all such matters confidential.

4. **Term:** The term of this engagement shall begin on the date hereof and shall terminate services (**30**) days from **0/0/20__** unless sooner terminated by **Auto Buying Assistant LLC**. In the event of an early termination no refund of the fee paid will be due unless termination is for failure of Consultant to perform the services provided for above in

which event the fee to which Consultant shall be entitled shall be equal to the amount of time spent in rendering the services multiplied by **\$49.00 per hour**.

5. In the event that it becomes necessary to enforce any of the terms of this agreement the defaulting party agrees to pay all reasonable attorneys fees incurred therein.
6. When the broker is operating the seller's (**Client Name**) vehicle to take pictures or to show to a potential buyer the seller is given Auto Buying Assistant (Brokering Services) permission to operate their vehicle and would assume any liability if it was involved in an accident which was or was not Auto Buying Assistant (**Brokering Services**) fault and would not hold ABA Brokering Services responsible for any damages both bodily or property.
7. This agreement shall be construed according to the laws of the State of Maine.
8. This agreement may only be modified in writing and contains the entire terms of the agreement between the parties.
